

**“Huhtamaki Make Your School More Cool”
Sweepstakes OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

The “Huhtamaki Make Your School More Cool” Sweepstakes (the “Sweepstakes”) is intended for legal residents of the United States of America and District of Columbia and is subject only to the federal, state, and local laws of the United States and the aforementioned jurisdictions. By participating, Entrants agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes. Winning a Prize (as defined below) is contingent upon fulfilling all requirements set forth herein.

ELIGIBILITY: Only open to K-12 Foodservice Operators (“Foodservice Operator”). By entering this Sweepstakes, you are entering on behalf of your employer, the Foodservice Operator. You must be legal residents of the United States and the District of Columbia, have reached the age of majority in their state of residence at the time of entry. Void outside the United States and District of Columbia, and where prohibited or restricted by law. Employees of Huhtamaki, Inc. and their affiliates, advertising and promotion agencies, the judging organization, and immediate family members (spouse, parents, children, siblings, and each of their respective spouses, regardless of where they reside) and persons residing in the same household, whether or not related, of each are not eligible to enter or win. Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

The Sponsor’s computer is the official time-keeping device for the Sweepstakes. Eligible Entrants may enter in one (1) of two (2) ways, as follows:

1. **Online Entry:** Visit <https://us.huhtamaki.com/schoollunch> and follow the directions provided to complete the online entry form to receive one (1) entry. Limit one (1) survey entry per K-12 Foodservice Operator throughout the Sweepstakes Period. All entries must be submitted from a K-12 Foodservice Operator issued email address. Personal email addresses will not be accepted. Entries received in excess of the above-stated limitation will be void. Automated entries are prohibited, and any use of such automated devices or programs, script, macro, or any other means which subvert the entry process will be void and will result in disqualification. Entries are the property of Huhtamaki, Inc. (“Sponsor”) and will not be acknowledged or returned. All entries must be received by 11:59:59 p.m. ET on June 13, 2019 to be eligible.
2. **Via Mail:** During the Sweepstakes Period, eligible Entrants can also enter the Sweepstakes by mail. Entrants can obtain one (1) Sweepstakes entry by legible print or type, on a 3”x 5” card or paper, their full name, complete mailing address, phone number, and e-mail address, and mailing the card in an envelope, with proper postage affixed, to: “Huhtamaki School Lunch” Sweepstakes, 9201 Packaging Drive, De Soto, KS 66018. All entries must be postmarked by June 13, 2019 and received by June 18, 2019. The postmark date of each mail entry will serve as the date of entry.

Incomplete entries will be disqualified. Released Parties are not responsible for: late, incomplete, incorrect, delayed, garbled, undelivered, or misdirected entries. All entries become the exclusive property of Sponsor and will not be acknowledged or returned. By participating, you consent for Sponsor to obtain, use, and transfer your name, address and other information for the purpose of administering this Sweepstakes and for other purposes as set forth below.

USE OF DATA: All information submitted by Entrants will be treated according to Sponsor's privacy policy, available at <https://www2.us.huhtamaki.com/privacy> By participating in the Sweepstakes and providing any applicable contact information, Entrants hereby agree to Sponsor's collection and usage of their personal information and acknowledge that they have read and accepted Sponsor's Privacy Policy.

GENERAL CONDITIONS: If for any reason the operation or administration of this Sweepstakes is impaired or incapable of running as planned for any reason, including but not limited to (a) tampering, unauthorized intervention, (b) fraud, (c) technical failures, or (e) any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, without notice and award the Prizes (as defined below) using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. Sponsor reserves the right, at its sole discretion, to disqualify any individual deemed to be (a) tampering or attempting to tamper with the entry process or the operation of the Sweepstakes; or (b) acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision

RELEASE AND LIMITATIONS OF LIABILITY: By participating in the Sweepstakes, Entrants agree to release and hold harmless the Sponsor, their respective parents, subsidiaries, affiliates, distributors, sales representatives, advertising and promotional agencies (collectively, the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of a Prize, including, but not limited to: (a) any technical errors that may prevent an Entrant from submitting an entry; (b) unauthorized human intervention in the Sweepstakes; (c) printing errors; (d) errors in the administration of the Sweepstakes or the processing of entries; or (e) injury, death, or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Entrant's participation in the Sweepstakes or receipt of Prize (defined below). Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. all eligible entries received during the Sweepstakes Period. Odds of winning a Prize will depend on the total number of eligible entries received during the Sweepstakes Period. The potential Prize Winner will be contacted by the Sponsor via phone, email and/or mail.

PRIZES: There will be one (1) Grand Prize awarded. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. The value of the Prizes set forth above represents Sponsor's good faith determinations of the ARV thereof and such determinations are final and binding and cannot be appealed. SEVERABILITY: The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. If any provision of the Official Rules is determined to be invalid or otherwise unenforceable, the other provisions will remain in effect and will be construed as if the invalid or unenforceable provision were not contained herein.
